### 2. Price

All prices are subject to change without notice. All orders accepted will be supplied at the price current at the date of shipment to the buyer, including items on back-order.

# 3. Title to the goods sold.

The property in the specific goods supplied by the Company to the buyer shall not pass to the buyer until payment in full for these goods has been received by the Company and the buyer's cheque has been honoured.
